Effective Emergency Management: Making Improvements for Communities and People with Disabilities. National Council on Disability (NCD)

In this report, the NCD describes evidence-based policies, programs, and practices that assist people with disabilities. Considerations are given to specific hazards that may have implications for people with specific disabilities. The document describes specific considerations for planning in the phases of mitigation, preparedness, response, and recovery (which are now categorized into the five preparedness mission areas of prevention, protection, mitigation, response, and recovery).

This guide for institutions of higher education (IHEs) was created by the U.S. Departments of Education (ED); Justice (DOJ), led by the Federal Bureau of Investigation (FBI); Homeland Security (DHS), led by the Federal Emergency Management Agency (FEMA); and Health and Human Services (HHS). The resource describes principles of emergency management planning, and a process for developing, implementing, and continually refining an emergency operations plan (EOP). The guide provides suggestions throughout for inclusive planning, such as ensuring the emergency planning team includes a representative of the AFN community.

The REMS TA Center, formerly called the Emergency Response and Crisis Management TA Center, provided this resource on integrating students with disabilities or AFN into plans. While the newsletter describes the four phases of a disasters, which has now been replaced with the five mission areas of preparedness, the strategies included within are still applicable. For example, the newsletter points out that schools can team up with a disability specialist who can provide guidance on meeting students' and staff's physical and emotional needs.

Communication with Vulnerable Populations: A Transportation and Emergency Management Toolkit. Transportation Research Board of the National Academies

This toolkit provides a guiding framework and tools for constructing a scalable, adaptable communication process to reach vulnerable populations through collaboration among the public, private, and nonprofit sectors. The toolkit provides specific recommendations throughout the four-step process of gathering information, building or adding to a network, communicating through the network, and sustaining the network. For example, when gathering information on needs, communities are encouraged to partner with entities such as schools, rural transport agencies, and state departments of transportation, among others.
